Follow 275 North to Exit 39, Tampa International Airport/ Hwy 60 West. Follow signs for 60 West towards Clearwater, Exit 2A.



At the second traffic light turn left on Bay Harbor Drive to the Bay Harbor Hotel.








ASQ Section 1508 Letter from the Chair


Do You Get Our E-Mails?
