Topic: “Myths of Lean Six Sigma Implementations ”

Main Speaker: Jaime Villafuerte, Lean Six Sigma Director, Jabil Inc

Summary: Despite the fact that many companies around the world implement Lean or Six Sigma, the vast majority of these deployment efforts failed. Studies show that only about 3 to 5 percent of Lean/Six Sigma deployment efforts are successful. What causes these efforts to fail? What makes well intentioned managers and teams fail? What did they miss? What can we learn from these efforts to increase our odds of success implementing Lean/Six Sigma? Today there is no shortage of books, certifications and consultants to aid in the learning and application of Lean/Six Sigma.

Most leaders are aware of their benefits and many have or will start their deployment. Yet very few companies have sustained the initial gains they made, much less built upon their early successes. 95 to 97 percent failure rate is a problem but it is also a massive opportunity to learn from these experiences and build up our own Lean Six Sigma efforts to harvest great rewards.

In this session, we will start by identifying several common warning signs of Lean/Six Sigma deployment efforts going in the wrong direction and then evaluate for possible causes using a practical, but effective model to understand interactions within a Lean/Six Sigma. This is a critical step, as most practitioners not only confuse symptoms with causes but they also have little understanding of the dynamics that make or break a Lean/Six Sigma deployment.

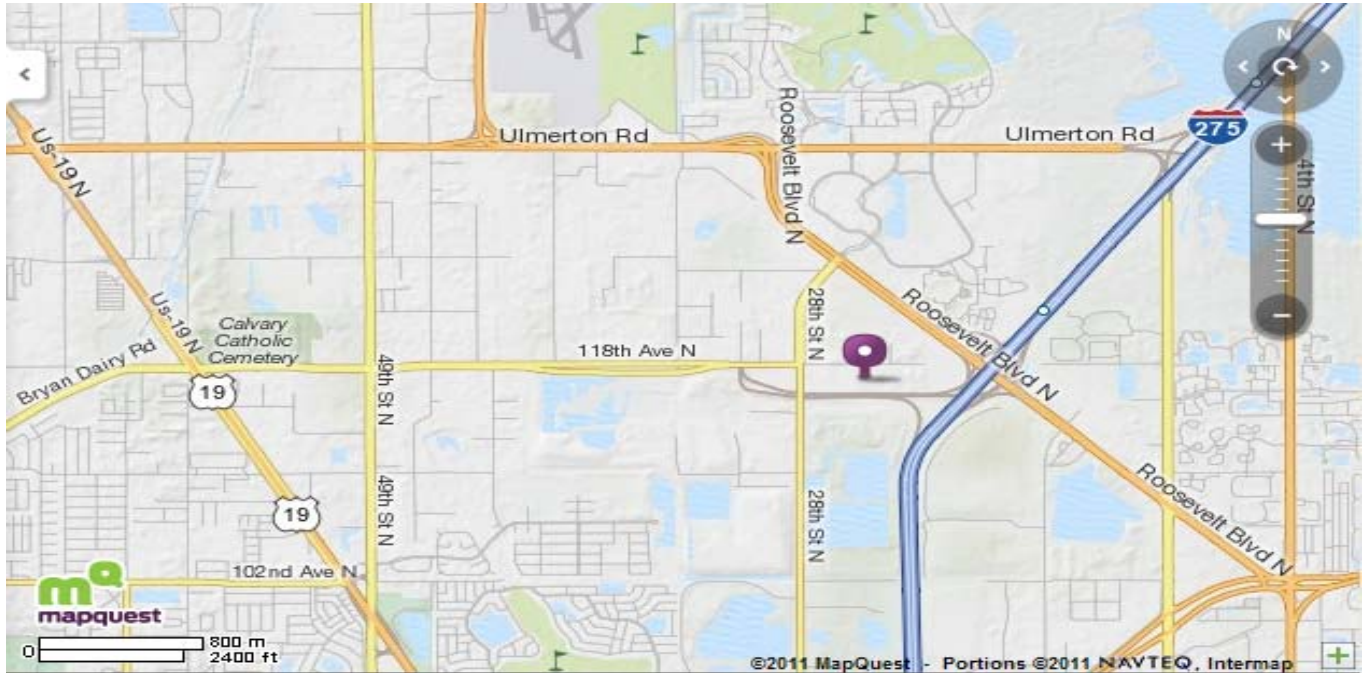


ASQ Certification for St. Petersburg/Tampa Section 1508
