November's Speaker

By ASQ chapter 1508-member interest survey, we were afforded the opportunity of being educated, and informed on the topic of Process Approaches to Quality Management System Design. Mr. Mick Howk shared his expertise on this matter.

Mick began to educate the attendees by walking us through the various steps of this process. This was done first by defining the "Process Approach", as specified per ISO 9001:2000, section 2. An example of the Process Model, which consists of Control (procedures), Input, Output, and Mechanism (resources), was explained along with various completion components, and applications. Some of these include System Linked Processes, Process Connect, Business Processes, and Quality Management Processes. Mick also used one example of a functional polypropylene plant process to better understand the components of the Product Realization Process.

Afterwards, Mick shifted gears, and guided the ASQ members, and guests through Process-Based Auditing, and Audit Planning concepts. They include identifying the business processes, analyzing the process identified inputs and outputs, determining the sequence of processes and interaction with other processes, identifying issues from previous audits, and creating notes for initiating audit trails.

Mick shared the SIPCO Process Model principals (Supplier, Input, Process, Output and Customer). A model of Process Affecters (Manpower, Material, Machinery, Methods, Measurement, and Environment or "Mother Nature") was presented, as well as detailed Process Measurement tools.

Mick provided a new outlook for some, and a different outlook for other ASQ chapter 1508 members, and guests. Our ASQ chapter attendees were grateful for the opportunity to learn, and expand once again.

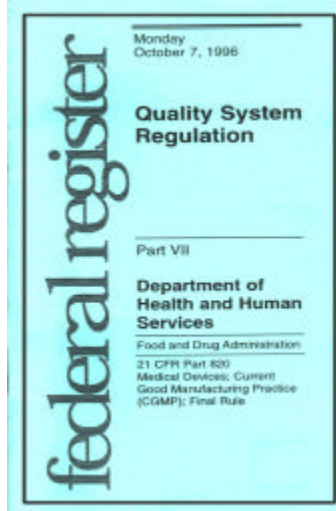

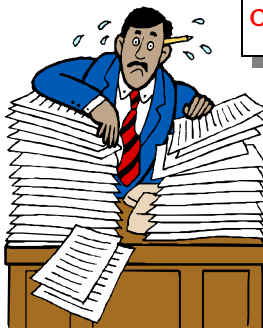
