ISO 14001:2004 – What's Changed?

In November of 2004, after several years of discussion and international negotiation, the International Organization for Standardization (ISO) published its revised environmental management system specification – ISO 14001:2004.

Organizations that are currently registered to ISO 14001 will only have a few months to upgrade their environmental management systems to meet the new requirements and organizations seeking registration must conform to the new standard immediately. Registrars must start auditing to ISO 14001:2004 in May, 2005 and certificates to ISO 14001:1996 will expire on May 15, 2006.

Ms. Dunmire will highlight the five most significant changes made in ISO 14001:2004 and discuss the impact these changes will have on existing environmental and quality management systems. She will conclude her presentation with a "crystal ball" discussion of the likely future of integrated quality, environmental and safety management systems in light of the standard "alignment" discussions already underway within ISO.

Biography: Thea Dunmire is the President of ENLAR Compliance Services, an environmental consulting company that specializes in assisting organizations in establishing environmental safety and health management systems. She is an engineer, environmental attorney, certified safety professional, certified industrial hygienist and RAB-certified EMS Lead Auditor. She is a member of the Technical Advisory Group to TC 207 and has participated in the development of the ISO 14001 standard. She has over 20 years of experience in assisting companies with complex environmental and safety issues. She is a professional speaker and author of a number of publications about environmental topics, including her newest publication: *Quick Guide to ISO 14001:2004 Transition* which is available on the ASQ web site.

“Stop Talking, Start Communicating”

Mark Wiskup promised to teach us how to “get good fast” at communicating in every business, networking and social opportunity. Part of the secret: realizing we must make a strong personal connection *first*. Mark then filled us with lots of tips we’re sure to actually use right away. Mark is a “coach” of winning communications and his unique program is designed to help audiences develop and flex their story telling muscles and connection skills. We worked-out those muscles at the meeting!

The next time we let our lips run, imagining the utterly fantastic wisdom we so freely offer, keep in mind that no one may be listening! The eyes and the nods may be indicating one thing, but the brain could already be on next week’s golf tournament! As Mark puts it, we best get over that shocking truth and arm ourselves with some strategies to connect with and be listened to.

Communication requires a sustained connection. Listen carefully and make that connection. Then, paint an interesting picture of what you are trying to convey that will keep your audience engaged, be it one person or many. Help your audience “see” success, and stay away from jargon, reciting facts, and all that dispassionate stuff we ASQers often excel at. Maybe you even have interesting stories to share.

Mark calls painting the picture of success a “Connection Power Tool”. But he went on to describe several more. One of the most powerful is resisting the instant answer. A good pause may show you are really considering the question. Explain your role in terms of what valuable things you do for your customers, not your title. Don’t be afraid to say you don’t know, but that you’ll get back with the answer. You will be rewarded with more credibility and a chance to prove you are willing to work for it. Accept compliments easily – then ask for more support!

Mark painted the rest of the picture with plenty of “Communication Killers”. We’ve all got to be careful with “as far as I know”, “probably”, etc. These phrases erode our connection. Get to the point right away- no one needs every detail. Avoid boring chronologies, excess use of numbers, and talking down: “basically...”, “as I said before...”, etc.

Mark, on behalf of the Section, thank you very much for helping us to “start communicating”. We enjoyed and appreciated your powerful messages.

Mark is the CEO of Wiskup Communications, Inc. His clients include Fortune 500 companies like Bank of America, Citibank, Verizon, Progress Energy, to privately held national and regional companies, to start ups. In his long and successful career, Mark was a television journalist in several states and founded a video production company growing to 20 employees. His first book, THE PRESENTATION EMERGENCY HANDBOOK, will be published by Warner Business Books in September 2005.

April's Pre-Dinner Presentation

Ms. Ellen Babb, Historian Pinellas County Heritage Village

Pinellas County's Heritage: What Historic Structures Tell Us About Our History

Recently the Section has been learning about our local community through some of the pre-dinner speakers, and in April we continued this trend. Ms. Ellen Babb presented a visual tour of several historic structures at Pinellas County's Heritage Village, and shared some interesting stories about our past.

Our historic structures relate to four important themes in the development of Pinellas County, starting with the McMullen Coachman Log Cabin of 1852. Ellen showed us how the lives of families and individuals intertwined with the themes of agriculture, coastal living, community life, and eventually tourism to create the paradise we have today. By 1900 there were more than 1000 McMullens living here, not to mention so many related families!

Did you know that as recently as 1960 "scrub cattle" drives were frequent across what is now Indian Rocks Road? Cotton "as far as the eye can see" helped propel the early economy. The Moore family turned citrus into a family agribusiness. When the Orange Belt Railroad extended its terminus to St. Pete it brought many benefits to the early tourism and sponging industries, and allowed the export of many crops.

Would you like to learn more about Pinellas County's cultural history? You may want to spend some time at Heritage Village, a part of Pinewood Cultural Park, 11909 125th St N, Largo, (727)-582-2123. You'll find 28 structures in good care on a beautiful site, just waiting to be explored.

Heritage Village is always looking to add to its collection of buildings and structures of historical significance, which are disappearing rapidly. Please report any buildings to Ms. Babb that you think might be good candidates to save.
