COMMON MISUSES OF STATISTICAL TOOLS IN SIX SIGMA PROJECT ANALYSIS - THE IMPLICATION TO THE BOTTOM-LINE

Despite the wide variety of statistical tools covered in Black Belt training, many Six Sigma project teams misuse statistics, with potentially negative consequences to the bottom-line of the project as well as to the future of Six Sigma as a whole within the organization. This presentation will identify and provide examples of several very common and potentially serious mistakes made during the statistical analysis of Six Sigma project data. It will also discuss the negative implications of these misuses of statistics as well as provide explanations for why they occur in order to identify practical solutions for them. This topic provides important information that can help any organization better ensure the success of its Six Sigma process improvement initiatives by avoiding mistakes common to a large number of Black Belt projects.
