FROM YOUR EDUCATION CHAIR

Thank you all for your continued support for the St. Petersburg / Tampa section's education program over the past three years! In 2008 - 2009 we provided 6 courses to 97 participants, which was an increase in participation of 21% from the previous year. The reviews were excellent and our training customer satisfaction scores were significantly better than other sections as well as ASQ as a whole! We plan to continue this successful trend in 2009-2010 and hope to reach even more people with this year's training program while maintaining our high standards for the courses offered. As always, we will need your continued support to ensure enough participation to keep all of these courses alive, so please tell your friends and co-workers about them. Everyone is welcome to attend but ASQ section members will continue to pay a lower price as a benefit of membership. (Of course we hope this will encourage others to join our section!)

Thank you also to all of you who provided input about what you'd like to see in this year's selection of courses. Finally, we have two important Education policy changes to share with you:

1. Most of our participants have been great about paying on time with no problems. Thank you!! Unfortunately, we have a few people who still owe the section money, despite repeated requests for payment, some for as long as two years. To encourage payment from those who owe us, our section board has adopted a new policy will allow us to post the names of those people who owe us money for training courses in the section's newsletter (something we already do for people who owe for dinner meetings). In order to ensure that sufficient advance warning is provided to those who owe, we will follow this procedure:

After each education class, the Education Chair will:

1. E-mail the list of people who owe money to the Treasurer
2. Contact each person on the list via email or phone
3. Wait at least one week for a response
4. E-mail again (if available) and leave a phone message
5. Wait at least one more week for a response
6. Call them again and send a letter to ASQ mailing address
7. Wait at least two more weeks for a response
8. Publish name as delinquent in the following month's newsletter

Note: No new training reservations will be accepted until the balance due is paid. Also, this does NOT in-



clude payments outstanding on Purchase Orders unless the P.O.'s are not paid within a reasonable time period.

2. Many companies now have Enterprise or Site memberships with ASQ. With these corporate memberships, our section does not receive the share of the membership fees that it does with Individual memberships. However, individuals from companies with Site or Enterprise memberships can become members of a local section for only \$20, and the section they join will then receive a portion of the \$20 as we do with Individual memberships. In the past, we have accepted people from companies with Site or Enterprise memberships as ASQ members for training price purposes and charged them the member price. In order to ensure that our section members are rewarded for their membership and support of our section, we will now require everyone to have an individual ASQ member number (preferably with our section!) in order to obtain the member pricing.

Please let me know if you have any questions, and be sure to pass this information along to anyone you think might be interested in attending. Your support is critical for us to be able to continue offering programs of this caliber at these prices. And don't forget that the RU's you receive from attending these courses will help you maintain those valuable certifications!

Thanks again for your support and I look forward to seeing you all again this year!

Free Local ASQ Job Placement Services

As a public service to Section 1508 members and local employers, we will post job openings and resumes on our website for three months at no cost. Resumes and job openings should be submitted in MS Word format to the Placement Chair (GuerryThode@gmail.com). In addition to new relevant job openings, job search tips, job fair information, etc. will be emailed to those on a *Confidential Email Job-Blast List*. Candidates interested in being on the list should email their request to the Placement Chair. Job postings must meet the guidelines shown below:

Ground rules for Web Site Job Postings

1. The standard web posting period is 3 months from the initial posting date.
 2. Postings may be extended after 3 months if approved by the Placement Chair.
 3. The posting employer or agency should notify the Placement Chair via phone or email **as soon as postings are filled or cancelled**.
 4. Generally, cancelled postings will be removed from the web site within 2 weeks of notification (4 weeks, maximum).
 5. Postings must be submitted electronically in Microsoft Word or RTF format.
 6. Postings should be less than 1 page long.
 7. Postings must provide contact information for those interested in the job.
 8. Job postings are public/community service of ASQ Section 1508 and the Section accepts no liability and make no claims regarding the content, accuracy or results of such postings.
 9. Initial posting dates and posting periods are not guaranteed.
 10. Postings must be for actual current job openings in the Tampa Bay area.
 11. Free placement agency postings are allowed for actual current job openings and must be accompanied with hiring company contact information to allow verification of opening. Company name and contact information will remain confidential (not published or communicated) if so requested by the agency.
 12. Companies/agencies may also place printed ads in the Section 1508 newsletter, *The Quality Quest*, at regular advertising rates.
 13. For job openings to be posted free on the web site, these ground rules must be agreed to by an employer or agency representative and such agreement shall be mailed, emailed, or delivered to the Placement Chair.
